## **Registration Fee Scholarship Request Form & Agreement**

As stated in Article III, Section 7 of Lakewood Youth Football Athletic Association by-laws we strive to provide financial assistance scholarship opportunities to our Youth Players and Cheerleaders for use within the LYFAA Program. Financial Assistance Scholarships when approved **are applied to annual league registration fees only**.

Football Players with scholarship should prepare to pay their uniforms fees: Adult Sizes (\$130) and/or Youth Sizes (\$120)

Cheerleads with scholarship should prepare to pay their uniform fees: Cheer Uniforms estimated \$250+ for Full Uniform & Poms.

We will have a limited number of Scholarship Rewards available each season. All scholarships requests will be reviewed in the order received; please submit your request to LYFAA Leadership Team promptly.

If player is approved for <u>100% Registration Fee Scholarship</u> LYFAA will require in return <u>8 hours</u> of your time volunteering for our program in the current season. If a request for <u>50% Registration Fee Scholarship</u> is approved, then LYFAA & Elite Cheer require <u>4 hours</u> of volunteer time this season. Volunteer activities include game day setup & clean up, concessions assistance, and other LYFAA volunteer opportunities as needed. If scholarship volunteer hours are not completed by end the season, your child may become ineligible for future financial assistance scholarships.

I understand that if I do not provide volunteer hours as committed this season my child may become ineligible for future financial assistance scholarships.

I understand scholarship funds will only be applied to registration fees and NOT Uniform costs. Football players and Cheerleaders using scholarships must be prepared to pay their uniform fees in full by season due dates. **Uniforms cannot be ordered if fees are not paid in full.**

Cheer Uniforms Fees are Estimated to be \$250+ (Adult & Youth Sizes)
